

Audi presents Golf Challenge - Prize Draw Terms and Conditions

- 1 By entering the Audi presents Golf Challenge Prize Draw (the **"Prize Draw"**), you confirm your acceptance of the following terms and conditions (the **"Terms"**).
- 2 The promoter of this Prize Draw is Volkswagen Group United Kingdom Limited trading as Audi UK (Company Number 00514809) whose registered office is at Yeomans Drive, Blakelands, Milton Keynes, MK14 5AN (the **"Promoter"**).
- 3 You will be legally bound by these Terms from the time you submit an entry to the Prize Draw, so please read them carefully before entering.
- 4 Any questions, comments or complaints regarding this Prize Draw should be directed to events@audipresents.co.uk.

CAN I ENTER THE PRIZE DRAW?

- 5 The Prize Draw is open to individuals who:
 - (a) are residents of the United Kingdom;
 - (b) aged eighteen (18) years or over;
 - (c) hold a UK driving licence;
 - (d) are an Audi presents member;
 - (e) hold a valid golf handicap;
 - (f) Have downloaded the VPAR app and have entered the [Audi presents Golf Challenge](#), with their VPAR app location settings turned on;
 - (g) Have played and scored a Stableford round on the VPAR app as part of the Audi presents Golf Challenge between 1 May 2025 and 31 July 2025 and have placed in the top 10 to be eligible to enter into the Main Prize Draw.
 - (h) Have played and scored a Stableford round on the VPAR app as part of the Audi presents Golf Challenge between 1 May 2025 and 31 July 2025 to be eligible to enter into the Monthly Spot Prize Draw.

by the end of the challenge on 31 July 2025 and at the time of notification of the Winner(s) (defined below). Each such individual is an **"Entrant"** for the purpose of these Terms.

- 6 Entry into the Prize Draw is free. No payment is necessary.
- 7 The Prize Draw is not open to employees of the Promoter, VPAR, their agents or contractors, the Promoter's retailers or to their immediate family members or persons living in the same household, whether or not related, or anyone else otherwise professionally connected with the Prize Draw.
- 8 The Promoter reserves the right to verify the eligibility of any Entrant and Winners and their compliance with these Terms. The Promoter may require such information as it considers reasonably necessary for this purpose. The Promoter may withhold prizes while it verifies eligibility.

- 9 Internet access, an email address and access to the VPAR app are required to enter the Prize Draw.
- 10 Entrants must enter their scores after each hole so their scores can be verified based on the time taken for the hole and the location on the golf course. VPAR will monitor the frequency of the score input function, based on the average hole and round time.
- 11 If an entrant does not have a valid handicap, they can obtain a VPAR handicap by scoring three (3) rounds in the VPAR app.

HOW TO ENTER – AUDI PRESENTS MEMBERS

- 12 The Prize Draw will open for entries at 10:00 (GMT + 0) on 1 May 2025 and will close for entries at 23:59 (GMT + 0) on 31 July 2025 (the "**Prize Draw Period**").
- 13 To enter, Entrants must do the following during the Prize Draw Period:
 - (a) Either:
 - (i) follow the instructions contained in a "call to action" email from Audi UK about the Audi presents Golf Challenge and log in to their Audi presents account; or
 - (ii) log into their Audi presents account directly;
 - (b) Navigate to the 'VPAR Audi presents Golf Challenge' page;
 - (c) Download the VPAR App, and score a Stableford round on the app;
 - (d) Place in the top 10 of the Audi presents Challenge, by 23:59 on 31 July 2025.

By scoring a Stableford round on the app, you are accepting these Prize Draw terms and conditions.

Restrictions on entry

- 14 Only entries completed and received by the Promoter during the course of the Prize Draw Period and in accordance with these Terms will be eligible for entry into the Prize Draw. No responsibility can be accepted for entries not received for whatever reason.
- 15 Only one (1) entry per person is permitted for the Prize Draw. Multiple entries from the same person and entries generated by script, macro, mechanical or other automated means are prohibited and will cause disqualification. Anyone found to have used multiple accounts to enter the Prize Draw will be ineligible. Multiple entries made through agents, third parties, organised groups or any entry duplication method will not be accepted.
- 16 The Promoter reserves the right to disqualify any Entrant and/or refuse to award a Prize or withdraw prize entitlement and/or refuse further participation in the Prize Draw, where it believes the Entrant not to be participating within the spirit of the Prize Draw or suspects the Entrant of engaging in any unfair or unjust behaviour. The Promoter reserve the right to use its discretion in all respects and to enforce any penalty or sanction it deems appropriate. The Promoter's decision will be final in this regard.

- 17 A geo-location based tracking system will flag any scores not inputted whilst on the golf course selected. Those inputted outside of the course location will be disqualified. All golfers must have their VPAR location settings on for the opportunity to feature in the top 10.
- 18 Entries that are not submitted in accordance with these Terms and/or that are delayed, damaged, incomplete, altered, illegible or otherwise defective (or which the Promoter cannot use to identify and contact the Entrant) will be disqualified.
- 19 The Promoter accepts no responsibility for entries or prize claims that are late, incomplete, incorrectly submitted, corrupted or misdirected, whether due to error, omission, alteration, tampering, deletion, theft, destruction, transmission interruption, communications failure or otherwise.
- 20 If at any time you wish to withdraw from the Challenge, please do so in the menu tab within the Audi presents Challenge itself.
- 21 If at any time you wish to withdraw from the Prize Draw, your request should be made in writing to the Promoter at events@audipresents.co.uk.

PRIZES

- 22 There are six (6) prizes to be won.

Main Prize Draw

- (i) The Winner will receive one (1) full set of TaylorMade clubs, one (1) custom fitting at The Belfry and dinner for two (2) in the Ryder Grill the day prior (26 August 2025) to the Audi quattro Cup UK Final on 27 August 2025. Overnight accommodation for two (2) will be provided at The Belfry on 26 August 2025 and entry into the Audi quattro Cup for two (2) on 27 August 2025.
- (ii) Second place will receive one (1) PowaKaddy FX1 18-Hole Lithium Electric Golf Trolley.
- (iii) Third place will receive one (1) Garmin Approach R10 Portable Golf Launch Monitor.

Monthly Spot Prizes

- (iv) There will be three (3) spot prizes with one available each month (May, June and July) with the Winner being selected via random draw of all players on the Scoreboard for that month. Each Winner will receive one (1): TaylorMade Pro Stand Bag.

SELECTION OF THE WINNER(S)

- 23 The Winner(s) will be drawn at random from all valid and eligible entries received and verified by the Promotor and/or its agent during the Prize Draw Period (the "**Prize Draw Winner**")
- 24 The Prize Draw Winner will be selected within 10 working days of the Audi presents Challenge ending on 31 July 2025.

- 25 In the event of any ties for prize position, qualifiers will be based on a form of countback (most Stableford points from the back 9 holes, then 5, 4, 3, 2, 1 holes of the Entrants qualifying round). All ties, after the countback process has been implemented will go through to the Main Prize Draw.
- 26 The selection process and Prize allocation is final and, therefore, no correspondence will be entered into thereafter.
- 27 The Prize Winner will be notified by email and/or telephone within 5 working days of the Prize Draw Winner(s) being selected. The Promoter will use the contact details supplied with the entry to contact the Prize Draw Winner(s) and will not be responsible if the contact details supplied to it are incorrect. **Please ensure that the email address you provide is valid in order for the Promoter to contact you if you have won.**
- 28 Entrants who have not won a Prize will not be notified.
- 29 When notified, the Prize Draw Winner will be asked to confirm:
- (a) Confirmation they are available on 26-27 August 2025 and can travel to The Belfry to accept their prize;
 - (b) Verification of their score and their valid handicap;
 - (c) their compliance with these Terms;
 - (d) if they accept the Prize;
 - (e) their name and email address;
- 30 If the Prize Draw Winner cannot be contacted or does not claim their Prize within two working days of notification after reasonable efforts by the Promoter, that Prize Draw Winner is not eligible for the Prize or has not complied with the Terms, the Promoter reserves the right (at its sole discretion) to withdraw the Prize from that Prize Draw Winner and pick a replacement Winner. No alternative Prize will be awarded to the original Prize Draw Winner.

WINNERS AND PRIZES

For the purposes of this section "**Winner**" shall include the Prize Draw Winner.

General

- 31 For the Main Prize Draw, there is a maximum of one (1) Prize per person. A Winner is permitted to accept a Prize from the Monthly Prize Draw and accept another prize from the Main Prize Draw should they be randomly selected from the top 10.
- 32 The Prizes are available to be won, but the Promoter makes no guarantees that all Prizes will be won (e.g. if there is low participation).
- 33 Where applicable, all Prizes will be arranged in accordance with COVID-19/Government guidance at the time of redeeming the Prize. If delivery or fulfilment of any prize will be delayed due to the COVID-19 pandemic and resulting Government restrictions, all Winners affected will be contacted by the Promoter and kept updated of any unavoidable changes and revised delivery/fulfilment dates.

- 34 Prizes are non-transferable and non-refundable. Winners must not seek to sell any Prize or advertise any Prize for sale, including on any digital platform or social media platform.
- 35 The Winner may be required to provide a valid form of government issued ID or other information on request by the Promoter. The Promoter reserves the right to withhold the Prize due to any discrepancies in the ID and/or evidence or other information required.
- 36 If the Promoter subsequently discovers the Winner is ineligible or has breached these Terms or is suspected of engaging in any other unfair or unjust behaviour then the Promoter reserves the right (at its absolute discretion) not to award the Prize to that Entrant and (in its discretion) either to award the Prize to another Entrant, who will be selected at random in the same way as the original Winner, or to include that Prize as part of the Wrap-up Draw. In that event the original Winner shall not be entitled to utilise the Prize. No alternative prize will be awarded to the original Winner.
- 37 There is no cash or other prize alternative to any of the Prizes.
- 38 If the Prize offered is unavailable, cancelled or suspended due to circumstances beyond the control of the Promoter, the Promoter has the right, but is not obliged, to offer an alternative prize of equal or greater value to the face value of the Prize. The Winner will not be entitled to any monetary equivalent or compensation for any costs or expenses incurred or suffered in connection with taking up the Prize.
- 39 All elements of a Prize must be taken at the same time.
- 40 Other than as set out above, the Winner will not be entitled to any reimbursement of travel or accommodation costs associated with their Prize. All such costs will be the sole responsibility of the Winner.
- 41 Where applicable, the Promoter's agent will transfer the spending money included as part of the relevant Prize to a bank account nominated in writing by the Winner prior to the date booked for travel. The Winner and their guest shall be responsible for any expenses incurred in the general use and enjoyment of the Prize in excess of the spending money.
- 42 Other than as set out above, the Prize does not include any additional meals and drinks, entertainment, spending money, personal and travel insurances, appropriate clothing, personal expenses, visas, vaccinations or any other costs not specifically mentioned as part of the Prize above. All such costs will be the sole responsibility of the Winner.
- 43 The Winner will also need to adhere to any other terms and conditions and/or disclaimers provided as part of the Audi presents Golf Challenge, noted here [on the challenge page](#).
- 44 The name and counties of the Winners and the Prize won will (unless the Winner has objected on lawful grounds) be made available on receipt of a self-addressed pre-paid envelope received by the Promoter for sixty (60) days following the end of the Prize Draw. The Promoter may disclose the surnames and counties of the Winners to the Advertising Standards Authority if required to do so.

PUBLICITY

- 45 Any Winner may be required to take part in non-paid publicity or advertising relating to the Prize Draw, which may include having their photograph taken for promotional and/or press purposes.
- 46 The Promoter reserves the right to feature the name, photograph and location of the Winner and their guest in any future marketing materials, website publications, promotions and/or prize draws.

GENERAL

- 47 In all circumstances, the Promoter's decision is final and no correspondence will be entered into.
- 48 The Promoter may change these Terms or cancel the Prize Draw at its absolute discretion in the event of circumstances outside its reasonable control, which it considers make it necessary for it to do so.
- 49 The Promoter accepts no responsibility for (a) any entries which are not received due to the use of incorrect or inaccurate entry information, any faulty or failed electronic data transmissions, or for any other reason; (b) any unauthorised access to, or theft, destruction or alteration of entries at any point in the operation of the Prize Draw; (c) any technical malfunction, failure, error, omission, interruption, deletion, defect, delay in operation or communications line failure, regardless of cause, with regard to any equipment, systems, networks, lines, satellites, servers, computers or providers used in any aspect of the operation of the Prize Draw; (d) inaccessibility or unavailability of any network or wireless service, the Internet and/or any website; or (e) any injury or damage to any person's computer(s) or mobile device(s) which may be related to or result from any attempt to participate in the Prize Draw or to download any materials in connection with the Prize Draw.
- 50 The Promoter is not responsible for events outside its control or for any losses arising as a result of events outside of its control. Nothing in these Terms shall have the effect of excluding or restricting the Promoter's liability where it would be unlawful to do so. This includes liability for (a) death or personal injury caused by the negligence of the Promoter or its employees, agents or sub-contractors, (b) fraud or fraudulent misrepresentation, and/or (c) any other matter for which it would be unlawful for it to exclude or attempt to exclude their liability.
- 51 The Promoter reserves the right to delay, postpone or cancel the Prize Draw in the event of a catastrophe, war, civil or military disturbance, act of God, further COVID restrictions affecting the Prize, or any actual or anticipated breach of any applicable law or regulation or any other event outside of the Promoter's reasonable control. Any changes to the Prize Draw will be notified to Entrants as soon as possible by the Promoter.
- 52 The Promoter will award the Prize as described in these Terms, but the Promoter accepts no responsibility or liability for the Winner's use of the Prize.
- 53 If there is a conflict in these Terms with any other terms whatsoever in respect of the Prize Draw, these conditions will apply.

- 54 Each of the paragraphs of these terms and conditions operates separately. If any court or relevant authority decides that any of them are unlawful, the remaining paragraphs will remain in full force and effect.
- 55 The Prize Draw and these Terms (including any non-contractual disputes or claims arising out of them) will be governed by the law of England and Wales. Any disputes must be referred to the English courts. Consumers in Scotland may additionally bring an action in their home courts.
